
1. CTA's Institute for Teaching (IFT) supports educator-driven change;

# WELCOME

Welcome to the Summer Institute 2010!

CTA members will face many challenges in their classrooms and schools, in their local chapters and on a statewide level. The 2010 Summer Institute provides classes and instruction to help members meet these challenges and to succeed in their leadership roles. Participants are enrolled in trainings that cover:

- **Bargaining Skills** – offered at two levels: **Essential Bargaining Skills** is designed to build the skills of bargaining team members and **Advanced Bargaining Skills** is designed for negotiators who have previously completed the Essential Bargaining Skills track, or who have at least three years of experience on a local bargaining team
- **Communications** – offered in three separate tracks: *Chapter Newsletters from A to Z*, *Online Activism: Engaging Your Members through your Website and Social Media*, and *Effective Communications: Using News and Public Speaking*
- **Emerging Leaders** – an intensive program for newly identified and elected leaders. This track is designed to provide information, resources and skills necessary for effective relational organizing and member advocacy
- **Healthcare Benefits and Issues for Active Members and Retirees** – focusing on member education of current local, state and national medical healthcare trends
- **Member Benefits** – presenting programs, products and services offered by CTA to promote local membership enhancement and recruitment
- **Legal** – offered in two tracks: Legal Track I focuses on group labor and employment issues ranging from basic union issues to employee rights; Legal Track II focuses on individual labor and employment issues
- **IPD Strand (IPD): QEIA and PI** - as schools transition from responding to the requirements of program sanctions to the operational phase of “no sanctions,” CTA’s IPD department is partnering with the Association of California School Administrators (ACSA) to provide an invaluable professional development which includes examining and redefining leadership, teamwork, collaboration and school climate and culture for improving schools
- **Community Outreach** – will provide local chapters with tools for getting an outreach project underway, and for engaging members, leaders and community organizations
- **School Finance** – for association leaders and bargaining team members who want to become more knowledgeable about school finance and school district budgets

The Summer Institute also offers social activities that will give participants numerous opportunities to meet each other and exchange ideas, suggestions, success stories and new ideas to try back home. Be sure to take advantage of these opportunities to round out your Summer Institute experience.

The CTA Board of Directors, the Summer Institute Planning Committee and CTA staff welcome you to the 2010 Summer Institute! ## GENERAL INFORMATION

### INFORMATION DESK

The CTA offices are located in the De Neve Plaza Podium Recreation Lounge and the Sunset Village Canyon Point A3 Lounge. CTA personnel will be available to assist you from Monday through Thursday, from 8:00 am to 5:30 pm and Friday from 8:00 am to 11:00 am.

### INSTITUTE HOSTS

Summer Institute Planning Committee members wearing yellow committee shirts will be available to assist you throughout the week.

### MEALS

Meals are served daily in the dining rooms in De Neve Plaza Podium and Sunset Village Covel Commons buildings beginning with dinner Sunday. For lunch each day, please use the dining room nearest your training sessions. Other meals are available in the dining room located nearest your sleeping room.

### ACCESS CARDS

Sunset Village and De Neve Plaza housing entrances are secured 24-hours a day. All participants receive an access card to be used when entering dining rooms, housing and training rooms located in residential buildings. All access and guestroom cards must be returned to the UCLA housing desk at the end of the Institute.

### COMMUTER ACCESS CARDS

Commuters are issued an access card to be used for access to training rooms and to the dining rooms for meals which are included in the commuter conference registration fee. Please return your access card to the CTA Desk at the end of the conference.

### COMMUTER MEALS

Meals for commuters are Sunday dinner, breakfast and lunch Monday to Friday.

### HOUSING INSTRUCTIONS

Check-out is 12:00 pm. Instructions for storage of luggage are included in the registration material.

### PARKING

Parking permits for those who requested parking during online registration are issued by CTA when you pick up your registration packet upon arrival. A valid parking permit must be displayed in vehicle each day, with each date covered beginning at 12:00 midnight. Failure to obtain and properly display this permit may result in a parking fine (and possible towing). Individual daily permits are available in the CTA office. Please note: "Do Not Park" signs are posted above eye level. UCLA is very diligent about giving parking violation tickets.

### CONFERENCE CENTER SHUTTLE SERVICE

While the UCLA Conference Center layout provides an opportunity to enjoy the outdoors, shuttle service (mini vans with drivers) will be available for those who find the walk difficult when getting from one center to another. The vans will stop in the Sunset Village parking garage 1<sup>st</sup> level elevator area and in the loading zone outside of the De Neve building.

## EMERGENCY INFORMATION

In the event of an emergency, dial 911 from any house phone. We ask that you please take the time to complete the emergency information section on the back of your name badge. This information could be vital in case of an emergency. Included in this guide is information regarding local hospitals, urgent care facilities and pharmacies.

## ONLINE EVALUATION

The online evaluation will allow you to give us feedback regarding the overall conference. A few days after the conference, you will receive an email with a link to the online evaluation. Your responses are completely anonymous to us. The evaluation should take no more than a few minutes to complete and the data we receive is very valuable to CTA in helping to improve future Summer Institutes.

## UNIVERSITY CREDIT and PROFESSIONAL GROWTH HOURS

University credit will be available through California State University, Chico. Full-week participants are entitled to three semester units of credit. Partial week participants are entitled to one semester unit of credit. Each unit is \$60 payable by cash, check or credit card. You may register for units online at <http://rce.csuchico.edu/cta>. Full Institute participation is required. Please pick up a form at the CTA desks in De Neve Plaza and Sunset Village starting on Tuesday. Verification of university credit will be available online three weeks after the conference.

Confirmation of professional growth hours will be emailed within two to four weeks after the conference.

## DAVID A. SANCHEZ - CTA PRESIDENT

President David A. Sanchez brings a commitment to seeing that all of our public schools – where the 325,000 members of CTA work every day – get the resources they need to continue to provide a quality education for every student.

Sanchez has a strong record of accomplishments over his 30 years in the teaching profession. The first Latino president of CTA, his leadership skills caught the attention of *La Opinión* newspaper, which named him one of 80 Latino “Leaders of the Future” in California in 2006.

He has testified in Sacramento on class size reduction and other vital legislation, and campaigned for three successful statewide school bonds passed by voters since 2002 that provided \$35 billion to renovate our schools and relieve overcrowding. He helped lead the historic CTA campaign against the governor’s measures in the special election of 2005, which would have destroyed teachers’ due process rights and the education funding protections in Proposition 98.

Sanchez is bilingual and has been the voice of CTA radio commercials in Spanish for the past eight years. He believes that our society’s diversity makes us whole. He takes the helm of California’s largest teachers union at a time when nearly 48 percent of the student population is Latino, and 25 percent are English learners of many ethnicities. He believes we have to close the school resource gap if we are to close the student achievement gaps that challenge our schools of greatest need.

He believes all schools deserve adequate and equitable funding and wants to build on CTA’s Quality Education Investment Act of 2006. This law will provide nearly \$3 billion over seven years for proven intervention reforms such as smaller classes, more counselors and better training for teachers and principals at hundreds of our most disadvantaged schools.

Sanchez’s knowledge about education is also drawn from his parents, whose careers as educators inspired him to carry on a rich family tradition.

Since 1980, he has been a kindergarten teacher for the Santa Maria-Bonita School District in Santa Maria, Santa Barbara County, and has also worked as a community college instructor. He still calls Santa Maria home.

His mother, Amparo D. Sanchez, is a former teacher of the year who retired after teaching elementary school for more than three decades in San Luis Obispo County. His late father, Dr. David J. Sanchez, for 23 years headed the Department of Ethnic Studies and Multicultural Education at California State Polytechnic University, San Luis Obispo. An elementary school in Santa Maria was named after the senior Sanchez in 2004.

David Sanchez’s CTA leadership experience includes serving four years as the union’s statewide secretary-treasurer and four years as vice president, plus several years on the Board of Directors representing a coastal region that includes about 20,000 teachers.

He holds a bachelor of science degree in early childhood education from Cal Poly in San Luis Obispo, and also earned a bilingual cross-cultural multiple subjects teaching credential from Cal Poly. His master’s degree in education is from the University of La Verne in Los Angeles County.



## DEAN E. VOGEL – CTA VICE PRESIDENT

Vice President Dean E. Vogel brings unique skills to the CTA leadership team with his broad background as a public school teacher and counselor at the elementary and higher education levels.

As CTA secretary-treasurer for four years, he oversaw the association's budget and expenditures. During the 2005 special election campaign, he appeared in numerous debates and rallies, did media interviews and walked precincts with state education leaders, talking to voters about the dangers of the initiatives on the ballot.

Vogel's teaching and counseling career spans 34 years. He has taught all elementary grades, including kindergarten, and has trained counselors and student teachers.

He understands educators and their needs. Since 1990, Vogel has worked as an elementary school counselor in the Vacaville Unified School District in Solano County. He speaks out strongly about the impact of California's having the fewest counselors per student of any public school system in the nation.

In Vacaville, he was a counselor's counselor. As a master counselor for university field study students, he trained many pupils who went on to become school counselors. He helped to develop a unique community counseling center that was housed on the campus of a Vacaville elementary school, where it served students and the public.

For his commitment to counselors, he was named "Advocate of the Year" by the California Association of School Counselors in 2006.

He's also taught extended education courses at three California State University campuses in Sacramento, Sonoma, and Hayward, and at the University of California at Davis. In addition, he spent 10 years as a resident teacher in the University of California Teacher Education Program, working with student teachers and helping the university develop its program for pre-service and in-service educators.

His counseling work was preceded by a teaching career of some 18 years in Vacaville, where he was named a local teacher of the year and was one of the first mentor teachers in Vacaville Unified.

Vogel has served in a variety of positions within CTA. His activism with the Vacaville Teachers Association included three years as president. He was elected to the statewide CTA Board of Directors in 1996, representing 20,000 educators in nine Northern California counties.

A graduate of public schools, Vogel was born in Idaho and grew up in Chino in Southern California. He earned a bachelor of science degree in social sciences from California State Polytechnic University, Pomona, and received his elementary teaching credential from UC Davis. At CSU-Sacramento, he earned a master's in education/group dynamics and a pupil personnel services credential.

He lives in Davis in Yolo County with his wife, Nancy Hiestand, who is a teacher in the Vacaville district, where the two educators met on the job. Vogel has three grown daughters and five grandchildren.



## GAIL M. MENDES, CTA SECRETARY-TREASURER

Secretary-Treasurer Gail M. Mendes, a passionate advocate for California's teachers and education support professionals, is a veteran Bay Area educator with more than 30 years of experience. She brings that experience and passion to her new role on behalf of these educators, whom she says are at the heart of our schools.

Currently a fourth-grade teacher at Bayview Elementary School in San Pablo, Mendes has taught students ranging from preschool age to senior citizens enrolled in Adult Education classes. She worked as a resource specialist and taught in Special Education before becoming an elementary school teacher. Mendes has spent most of her teaching career in the West Contra Costa Unified School District, although she got her start in the Oakland Unified School District.

As a classroom teacher and immediate past president of the 2,000-member United Teachers of Richmond, Mendes knows well the challenges of rural and urban schools, all of which compose the seven-city West Contra Costa School District. In her years of teaching in the financially strapped school district that has been under state receivership, Mendes can attest to the importance of working in well-run, well-funded schools that are supported by the administration and are accountable to the community.

Her longtime experience teaching in a chronically underfunded school district propelled her into becoming active in her local chapter. In addition to her position as chapter president, Mendes has also served as a site representative at her school, area director and vice president of her local association, and as a representative to the CTA State Council of Education, where she served both on the Human Rights and Budget Committees. Her work on the CTA Budget Committee provided her with the knowledge and grounding to run for the position of CTA Secretary-Treasurer. Mendes has also been active politically in several elections and was called on to represent the Alliance for a Better California labor coalition in community forums on the governor's ill-fated Propositions 74, 75 and 76 in 2005.

Mendes hopes to use her passionate advocacy skills to further energize CTA's 325,000 members to become even more involved and active in their chapters and their union, which she sees as California's best hope for obtaining the funding our public schools need to serve the state's 9 million K-14 students.

A graduate of California State University, East Bay with a bachelor's degree in Human Development, Mendes completed her master's degree in education at St. Mary's College in Moraga. She has both a lifetime multiple subject and special education credential, and is NCLB compliant.



**TOM TORLAKSON**  
**CALIFORNIA STATE ASSEMBLY**  
**CANDIDATE FOR SUPERINTENDENT OF PUBLIC INSTRUCTION**

Assemblymember Tom Torlakson is a second-generation teacher who has applied his experience as a science teacher and high school coach to fight for our kids and reform the way public education works in California. Tom has fought to improve student nutrition and physical education and to give schools the funding support they need.

Tom's journey has led him from the classrooms of Contra Costa County's Mount Diablo Unified School District (where he remains a teacher-on-leave), to the Antioch City Council, Contra Costa County Board of Supervisors, and the California State Senate and State Assembly.

Improving our state's public education system has been the top priority for Tom as a member of the Legislature.

In 1998 Tom authored legislation that has led to the development of the largest system of after school programs in the nation. In 2006, he authored the bill that led to a 300 percent expansion in these programs—so they now reach 4,000 schools around the state. Tom authored the Quality Education Improvement Act in 2006, which dedicates nearly \$3 billion to our lowest performing schools. Tom also played a key role negotiating and authoring the \$9 billion Proposition 1A bond measure in 1998—which has led to public votes supporting over \$35 billion to build new schools and improve existing school buildings.

Tom championed legislation to increase funding for textbooks, computers and other instructional materials; bills to enhance campus safety, close the digital divide, eliminate the achievement gap, improve student health and reduce the horrible drop-out rate. Tom has also authored legislation to improve the safety of our children and students—including landmark legislation to regulate amusement park rides, improve reporting of sexual assaults and other crimes against children, combat hazing and make our schools safer for students and teachers.

As the chair and founder of the California Task Force on Youth and Workplace Wellness, Tom has been a leader on banning junk food from our schools, providing healthier school meals and promoting student health and fitness.

Tom is running for State Superintendent of Public Instruction so he can fight for our kids. He wants to ensure parents can send their children to a safe, quality school in their own neighborhood. He will seek to expand career and technical education for high school students, protect college-prep courses and arts and music programs and make sure the management of local school districts measures up to the highest standards of excellence.

Born in San Francisco, Tom served as a fireman in the United States Merchant Marine, earning the Vietnam Service Medal. He attended College of San Mateo before going to the University of California, Berkeley and earned a B.A. in History, a Life Secondary Teaching Credential and an M.A. in Education.


