CTA Board Member Jim Groth spoke on the budget and layoff notices. Silver Wing Parent Gabriela Wallace spoke on the budget and its impact on the school. CVCEO Co-Presidents Ernie Gutierrez and Juan Marin spoke on behalf of the Classified Organization regarding its upcoming bargaining sessions.

Mr. Bejarano:

- Thanked Ernie and Juan for their remarks regarding CVCEO's upcoming bargaining sessions.
- Mentioned that the layoff notices are a proposed action that must be done prior to March 15—nothing is final until we receive the Governor's May Revise. He stated, "We will continue to work through the process during these very difficult times and consider all options."
- Thanked everyone who submitted emails or contacted him regarding the potential layoffs and budget.
- Congratulated the winners and all the students who participated in the speech contest.

Mr. Coronado:

- Congratulated speech contest winners Sierra Leeper, Cassandra Luna, and Brent Avery.
- Congratulated CVLCC, Harborside, and Silver Wing for being recognized as Title I Achievement schools.
- Congratulated District schools nominated for distinguished school recognition.
- Echoed the remarks made by Mr. Bejarano regarding the layoffs and budget. He said, "This is not a done process and we are still working through it."
- Commented on the order of the agenda. He proposed to the Board that he would rearrange oral communications and reports as needed with their concurrence.

Mr. Cunningham:

- Congratulated the three winners of the speech contest and all the students who participated.
- Read at Olympic View during Read Across America Day in the Chula Vista Elementary School District and really enjoyed it.
- Thanked the school staff and parents who gave a summative presentation on their school. He said, "Great example of staff working hard for our students."
- Mentioned that the budget crisis regarding layoffs is a long process but, unfortunately, decisions must be made prior to March 15.

Mr. Luffborough:

- Thanked everyone who attended the meeting.
- Thanked everyone who contacted him regarding the layoffs and budget crisis. He appreciated the show of support tonight.
- Acknowledged and congratulated the speech contest winners.
- Mentioned that he is very appreciative of the Board. He feels that the Board will do what is best for students.
- Thanked staff for the presentations and for what they are doing.

Mrs. Smith:

- Congratulated the speech contest winners.
- Thanked the new sponsors of the speech contest.
- Thanked the schools for their reports.
- Congratulated Silver Wing and the other schools being considered for distinguished school recognition.
- Thanked Nancy Kerwin and Tina Williams for the report on the transition of the before- and after-school programs.
- Echoed the comments made by Mr. Bejarano regarding the budget. She mentioned that the Board will make the best decisions for the quality of education students deserve. The Board is committed to do what is right with integrity and a lot of thoughtfulness.

11. SUPERINTENDENT'S COMMUNICATION

Superintendent's Communication

Dr. Billings:

- Commented that the entire bargaining process is complicated. Our Classified Organization participates in interest-based bargaining, which allows them to sit down at the table, problem solve, share interests, and do a considerable amount of dialogue on budget and fiscal issues to eliminate the spread of misinformation.
- Thanked the present and past leaders of CVCEO for always being open and candid.
- Mentioned that California not only has a budget deficit, but also has many inequities. He said, "Not all districts are created equally," so the impact hits districts differently. As the largest K-6 District in the state, we are heavily impacted by anything that happens with Class Size Reduction. We have the lowest class size in any school district in the county—our average is 18.9 in K-3 and 28.9 in Grades 4-6 and we have one of the lowest base revenues limits in the county, which means that we receive less money per pupil. This means we do more with less from the get go. The District will do what is best for children in our community."
- Mentioned that it is the goal for every school in the District to be an 800 API school this year and we might see our first 900 API school. The District has a very bright future, high academic performance, wonderful children, a lot of opportunities, and one of the best teaching staffs in the state.
- Thanked Susan and the Finance Division for maintaining the budget reserves. He stated, "We have to be cautious as we approach the future, but we have reserves that most school districts do not have. I am confident that we will find the right blend of cuts that will still distinguish this District by continuing the highest quality of education for each child."
