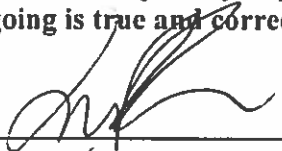

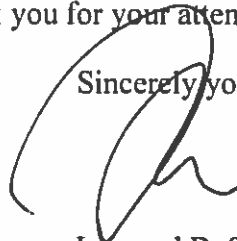

I. INTRODUCTION

Petitioners Betty Boone, Candace M. Carroll, Ed Chapin, Debra Coplan, Laura Fink, Martha Hall, David Higgins, Knut Johnson, Don Kripke, Jeffrey Lewin, Kasra Mohavedi, Neil Senturia, Leonard B. Simon,¹ Claudia Smith, Kate Yavenditti and Steve Yunker, all of whom are persons residing in San Diego County, and which group includes Republicans, Democrats and Independents, hereby complain to the Fair Political Practices Commission ("FPPC") as follows:

1. Gary G. Kreep was elected to Seat 34 of the Superior Court for the County of San Diego in the primary election held June 5, 2012, winning by less than one percent of the vote. Judge Kreep assumed his position on the bench on January 7, 2013.

2. During his campaign for this Superior Court seat, and thereafter, Judge Kreep and persons working on or on behalf of his campaign violated California law in several respects, as detailed below.

3. Complainants request that the FPPC investigate this matter thoroughly and impose such sanctions as are appropriate.

II. MISREPRESENTATIONS AND OMISSIONS IN OFFICIAL CAMPAIGN FILINGS WITH THE STATE OF CALIFORNIA

4. California law requires that political candidates, including candidates for judge, file certain disclosure forms. California Public Reform Act, Gov't Code §§ 81000 *et seq.* Judge Kreep failed to disclose, or inaccurately disclosed, several matters required to be

disclosed on these forms, thus depriving the electorate of full information regarding his candidacy.

A. Failure to Timely Disclose Contributions

5. California law has special disclosure rules for what are called "late contributions." Gov't Code § 84203. A "late contribution" is a contribution, including a loan, that totals in the aggregate \$1,000 or more and is made to or received by a candidate, a controlled committee, or a committee formed or existing primarily to support or oppose a candidate or measure within 90 days before the election. Gov't Code § 82036. State law requires that "late contributions" be reported by both the contributor and the recipient within 24 hours of the time they are made. Gov't Code § 84203. Judge Kreep's campaign, in concert with other political organizations that he chairs, appears to have used money laundering and "structuring" techniques to skirt these requirements and avoid disclosing certain transactions during the campaign.

6. In January 2012, Beat Obama-PAC, an organization controlled by Judge Kreep, contributed \$3,500 to the Republican Majority Campaign (RMCPAC), another Kreep-controlled organization. Exhibit 1, Beat Obama PAC 2012Q1 Amended FEC Form 460; Exhibit 2 (note that the group changed its name from "Draft Herman Cain PAC" in November 2011 to "Beat Obama Political Action Committee," but the FEC filings continued to show its name as Draft Herman Cain). RMCPAC did not report receiving the funds to the FEC. At the time of the contributions, Judge Kreep was chairman of both Beat Obama-PAC and RMCPAC. Exhibit 3.

7. On April 6, 2012, RMCPAC contributed \$999 to Kreep's campaign. Exhibit 4, RMCPAC FEC Form 3X, filed July 16, 2012; Exhibit 5, Gary Kreep for Judge California Form 460, filed July 31, 2012, at 5-6. The amount is \$1 less than the state's reporting threshold for late contributions. Gov't Code § 82036 and § 84203. RMCPAC made the contribution in two separate disbursements, possibly to avoid attention. At the time of the contributions, Judge Kreep was chairman of RMCPAC. Exhibit 3.

8. Also on April 6, 2012, RMCPAC transferred \$1,500 to Justice-PAC, another Kreep-controlled organization. Exhibit 6, RMCPAC FEC Form 3X, filed July 16, 2012; Exhibit 7, Justice-PAC FEC Form 3X, filed July 14, 2012. The same day, Justice-PAC contributed \$999 to Kreep's campaign. Exhibit 8, Justice-PAC FEC Form 3X, filed July 14, 2012; Exhibit 5 at 5. The amount is \$1 less than the state's reporting threshold for late contributions. Gov't Code § 82036 and § 84203. Justice-PAC made the contribution in two separate disbursements, possibly to avoid attention. At the time of the contributions, Judge Kreep was chairman of RMCPAC and Justice-PAC. Exhibit 3.

9. Thus, on April 6, RMCPAC effectively contributed a total of \$1,998 to the Kreep campaign, directly and indirectly, but did not report this contribution of over \$1,000 within the time required by law.

B. Failure to Disclose Income

10. California law requires that candidates for public office disclose their income during the reporting period. Gov't Code § 87201.

11. In 2012, California Public Safety Voter Guide, a slate mailer political entity run by Barrett Garcia and Jim Lacy, two individuals with multiple financial relationships

with Judge Kreep,² paid Judge Kreep \$34,000 for consulting services. Between May 20, 2012 and June 20, 2012, California Public Safety Voter Guide paid Judge Kreep \$12,500 for consulting services. Exhibit 13. Between October 21, 2012 and December 31, 2012, California Public Safety Voter Guide paid Judge Kreep \$21,500 for consulting services. Exhibit 14. Judge Kreep failed to disclose this income from the California Public Safety Voter Guide on his Assuming Office Form 700 filed on February 11, 2013. Exhibit 12.

C. Failure to Report Expenditures on Slate Mailers

12. California law also requires that political campaign committees report their expenditures to the California Secretary of State. Gov't Code § 84211(b); Cal. Code Regs., tit. 2, div. 6, § 18452. In July 2012, five slate mailer organizations controlled by Mr. Garcia and Mr. Lacy reported receiving over \$7,600 from Judge Kreep's campaign committee in June 2012 in payment for slate mailers in support Judge Kreep's candidacy. Exhibits 16-20. Judge Kreep's campaign committee did not report these expenditures as required by law.

² Garcia and Lacy run Taxpayers for Safer Neighborhoods, an "independent expenditure" group. Exhibit 9. Mr. Lacy runs Landslide Communications, a political marketing firm. Exhibit 10. Judge Kreep's campaign reported owing \$10,331 to Landslide Communications. Exhibit 11. Judge Kreep also reported earning \$10,000-\$100,000 as a consultant for Landslide Communications in 2012. Exhibit 12. This income was earned sometime between March 9, 2012 (Exhibit 3), and February 11, 2013 (Exhibit 12). Thus, Judge Kreep and his campaign were both paying money to Landslide and receiving money from Landslide during the campaign. In addition, Garcia and Lacy run five California "slate mailer" organizations to which Judge Kreep's campaign made payments totaling over \$7,600 in 2012, described below. Finally, California Public Safety Voter Guide paid Judge Kreep \$34,000 for "consulting services" in 2012 (Exhibits 13 and 14), and nearly \$60,000 in 2010 for consulting services on Lacy-connected slate mailers. Exhibit 15.

13. On July 25, 2012, Woman's Voice, a California slate mailer organization controlled by Mr. Garcia and Mr. Lacy, reported receiving a \$965 payment from Judge Kreep's campaign committee on June 18, 2012 for slate mailers to support Judge Kreep's candidacy. Exhibit 16. Judge Kreep's campaign committee did not report making this expenditure as required by law. Exhibit 21.

14. On July 23, 2012, National Tax Limitation Committee Newsletter, a California slate mailer organization controlled by Mr. Garcia and Mr. Lacy, reported receiving a \$2,050 payment from Judge Kreep's campaign committee on June 18, 2012, to support Judge Kreep's candidacy. Exhibit 17. Judge Kreep's campaign committee did not report making this expenditure as required by law. Exhibit 21.

15. On July 23, 2012, Save Proposition 13 Segregated Fund Account, a California slate mailer organization controlled by Mr. Garcia and Mr. Lacy, reported receiving a \$1,820 payment from Judge Kreep's campaign committee on June 18, 2012 for mailers to support Judge Kreep's candidacy. Exhibit 18. Judge Kreep's campaign committee did not report making this expenditure as required by law. Exhibit 21.

16. On July 23, 2012, Small Business Action Committee Newsletter, a California slate mailer organization controlled by Mr. Garcia and Mr. Lacy, reported receiving a \$1,300 payment from Judge Kreep's campaign committee on June 18, 2012 for mailers to support Judge Kreep's candidacy. Exhibit 19. Judge Kreep's campaign committee did not report making this expenditure as required by law. Exhibit 21.

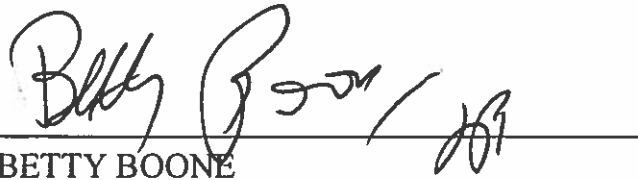
17. On July 23, 2012, California Public Safety Voter Guide, a California slate mailer organization controlled by Mr. Garcia and Mr. Lacy, reported receiving a \$1,496

payment from Judge Kreep's campaign committee on June 18, 2012 for mailers to support Judge Kreep's candidacy. Exhibit 20. Judge Kreep's campaign committee did not report making this expenditure as required by law. Exhibit 21.

III. CONCLUSION

Judge Kreep violated California law in several respects in his campaign. These are serious matters and should be investigated fully. Attorneys and those who wish to become judges should be held to particularly high standards in complying with the law.

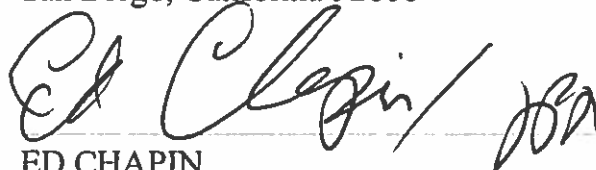

Who's behind Gary Kreep robocall?

Super PAC launched a last-minute campaign to mislead voters

More than a month after the primary election, we're still wondering how right-wing, "Birther" attorney Gary Kreep received a majority of the votes in his race for a San Diego County Superior Court judgeship. The mystery was further complicated when *Voice of San Diego* analyzed the precinct data and found that Kreep did exceptionally well in southern San Diego, an area of predominantly Democratic and Latino voters whom one wouldn't expect to support a candidate linked with the Minutemen movement.

One anonymous reader in the South Bay suggested it may have something to do with a last-minute robocall from a group called Taxpayers for Safer Neighborhoods (TSN) that attacked Kreep's opponent, Deputy District Attorney Garland Peed. The call, a recording of which was provided to *CityBeat* (listen below), said Peed would be the "worst kind of county judge," claiming that his use of plea bargains put drug dealers back on the streets.

"Brian Moore, convicted three times of drug dealing and firearms charges, and all after Garland Peed plea bargained him in 1993. Gang member Moore finally went to state prison in 2009."

Our research indicates that the call conflated two different criminals named Brian Moore. Brian Dennis Moore, who was convicted in 1993 on robbery charges, has been in state prison on and off for 20 years and is currently at High Desert State Prison in Susanville, Calif. Brian Eugene Moore, who went by the name "Hot Dog" in the Eastside Piru gang, was the one convicted in 2009 for dealing cocaine. He was sentenced to four years in prison.

Taxpayers for Safer Neighborhoods also broke the law: Robocalls are illegal in California unless they're introduced by a real person. This one was not.

The call isn't one Kreep could have made himself, since the California Code of Judicial Ethics forbids judge candidates from making misrepresentations concerning their opponents. Instead, Kreep's friends said it for him.

The political action committee (PAC) did not return our messages. It lists one of its directors as lawyer James Lacy, a conservative activist and chairman of Western Conservative Political Action Conference. Kreep serves as WCPAC's vice chair and counsel. TSN's treasurer, Barrett Garcia, also has a history with Kreep. Garcia paid Kreep almost \$60,000 in 2010 for consulting on Lacy-linked slate mailers.

The PAC typically focuses on elections to the north, including the La Puente City Council and Orange County judicial races this cycle. In 2010, the committee spent money on races in San Juan Capistrano and Dana Point. Information regarding who funded the anti-Peed robocall won't be available until early next month; the committee did not file the reports required by the state within 24 hours of a \$1,000 independent expenditure.
